I, Ganesh Jung of lawful age, being first duly sworn upon oath, state and affirm the following:

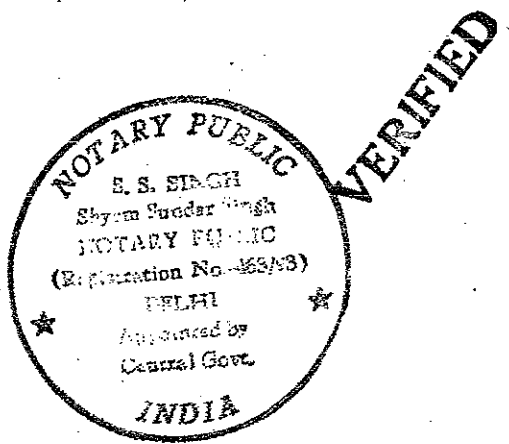
1. I am a native of India and am the Uncle of Renu.
